Sheep need to gain a minimum of .4 per day and min weight of 115 to sell
3. Swine –
Make sure to schedule to get your health certificate from vet for swine inspection

4. Poultry/Rabbits –
Pollurium Testing is waived this year by state, be on safe side and have your hatchery papers for young birds.
