Introductions, Overview of Agenda – Keith West, CAC Co-Chair

USACE Aquatic Plant Control for Rookery Habitat project summary and discussion

- Kris Erickson, Ecology and Environment, Inc.
- Kris shared handouts and described project to the group
- USACE has secured funding through their Aquatic Plant Control Research Program for invasive species management on Lower Menominee islands (Blueberry, Little Blueberry, Boom, and Strawberry)
- This project is a Detroit District project that also includes technical expertise from USACE's Engineering Research and Development Center (referred to as ERDC), Buffalo District, RAP coordinators, TAC, CAC, and other interested regional partners.
- 2 ½ year project, to end in 2016
- First two years initiate baseline mapping, invasive control activities, and restoration plantings (which may occur toward end of second year or in third year)
- Third year will involve adaptive management through detailed monitoring
- Kris—Besides target species (buckthorn, honeysuckle, grape), they also observed small Phragmites stand on Strawberry, some reed canary grass other islands, sumac on Boom
- Will definitely treat Phragmites, but other two not certain yet
- Kris—Contractor bid package out in December for cutting and spraying, hoping for local companies to respond
- Others—Might not get many responses due to scale of project and special needs (islands)
- Keith—Will bird monitoring be bid out? Interested in helping with that (UW-Marinette students)
- Kris—Plan is for ERDC and E & E to conduct the migratory, nesting, and treatment bird monitoring but the Project Team is definitely open to securing local help and interest
- Kris—Need for outreach, collaboration, plan for future—local stewardship
- Keith—Interested in being involved along with his students
- Trygve—Local Audubon chapter—Wendel Johnson is main contact (was at TAC meeting)
- Jon—Need to consider human activities on islands—If open up Strawberry by treating invasives, might attract more people
- Also, will you control access during treatment?

- Kris—Yes, will need to consider human access and activities on the islands
- Keith—Does project fit in with AOC goals and schedule?
- Laurel—Yes, fits in with objectives and goal to complete management actions by 2016
- Kris—Yes, project was funded to support AOC goals and schedule
- Will continue to involve AOC groups to ensure project meets local objectives
