

# Tyrol Basin Snow School 2022-2023 Registration and **RELEASE OF LIABILITY**

I understand that there are risks, dangers, and hazards associated with the sport of skiing in its various forms including snowboarding, that may cause serious personal injury or death and that injuries are a common and ordinary occurrence in this sport and in this snow school. In consideration of my participation in classes, instruction and/or lessons by the Snow School and the use of Tyrol Basin facilities, **I RELEASE AND FULLY DISCHARGE TYROL HOLDINGS, LLC its owners, officers, shareholders, instructors, agents, and employees (collectively the "TYROL BASIN RELEASEES") from any liability resulting from any personal injury which is caused by NEGLIGENT ACT OR OMISSION of any TYROL BASIN RELEASEE with respect to:**

- The preparation, organization, coordination, operation or supervision of the TYROL BASIN Snow School, its instructors, or its classes, instructions or lessons;
- Classes, instructions or lessons given or not given to me;
- The selection of the ski run for the lesson(s);
- The design, location, construction, inspection, and maintenance of table top, step up and step down jumps, and other jumps including hips and spines, together with their height, their start location and the angle and length of their approaches, take-off ramps and landing areas;
- The design, location, construction, inspection, and maintenance of all other terrain features, including rollers, rails, boxes, wall rides, and pole jams, together with the angle and length of their approaches, take-off ramps and landing areas;
- Grooming, snowmaking, and snowmobile operations and equipment, the operation of chairlifts and conveyor and handle tows, and chairlift and conveyor and handle tow loading, riding, and unloading operations for the TYROL BASIN Snow School, including the presence or absence of restraint bars on the chairs;
- The padding or non-padding of natural and man-made obstacles and hazards on, adjacent to, or off the skiable terrain;
- The posting or failure to post warnings and signs, and the construction of or non-construction of fences or other barriers, including the selection of the construction materials;
- The classification and labels of trails, ski runs, and terrain features; and
- The presence of snowmaking pipes, hydrants, guns, wants, and other snowmaking equipment, light poles, rocks, and trees on and adjacent to the ski runs.

I understand that for a fee of \$25.00 in addition to the normal snow school fee, TYROL BASIN offers an optional Snow School Agreement which does not require signing a release of liability. In signing this Release of Liability, I acknowledge I am aware of this option offered by TYROL BASIN and hereby waive my right to purchase said option.

**I HAVE CAREFULLY READ THIS SNOW SCHOOL RELEASE OF LIABILITY AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS SNOW SCHOOL RELEASE OF LIABILITY, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE TYROL HOLDINGS, LLC ITS OWNERS, OFFICERS, SHAREHOLDERS, INSTRUCTORS, AGENTS OR EMPLOYEES FOR THE ABOVE NEGLIGENT ACTS OR OMISSIONS.**
