

**Jefferson County Master Gardener Volunteer Association Meeting**

1. General Meeting - Called to order by President Dennis B at 6:45 pm

4. Diane K reported that the WIMGA Annual Conference is March 28-29, 2014 in Appleton. Reminder: We, the Jefferson County Master Gardeners, will be doing the 2017 State WIMGA Conference.

5. Sue Z reported that 2 out of the 3 WIMGA 2013 Educational Grants submitted in Sept were awarded to JCMGVA. That means that 7 of our 8 grant proposals in the last 4 years have succeeded. The two grants awarded this year are the \$400 grant for WE Grow for a handicap accessible plant table at West Elementary School and the \$250 grant for the MG Banner with the new logo to be used for JCMGVA events. Grant proposals for next year's \$150 grant can be submitted to Sue Z by the April meeting so that she has enough time to prepare them before the Oct 1 deadline. We cannot apply for the \$400 grant again until 2015.

6. Mary T reported that today's speaker is Frank Hassler of Good Oak. The topic for the January 9, 2014 meeting will be Seed Saving by Rock County Extension Agent, Christine Marsden, who has worked for Seed Savers Exchange. Hopefully, Susan Mahr will be here for our February meeting. Judy F and Mary T requested that the membership continue to provide topics of interest and suggestions for possible speakers.
