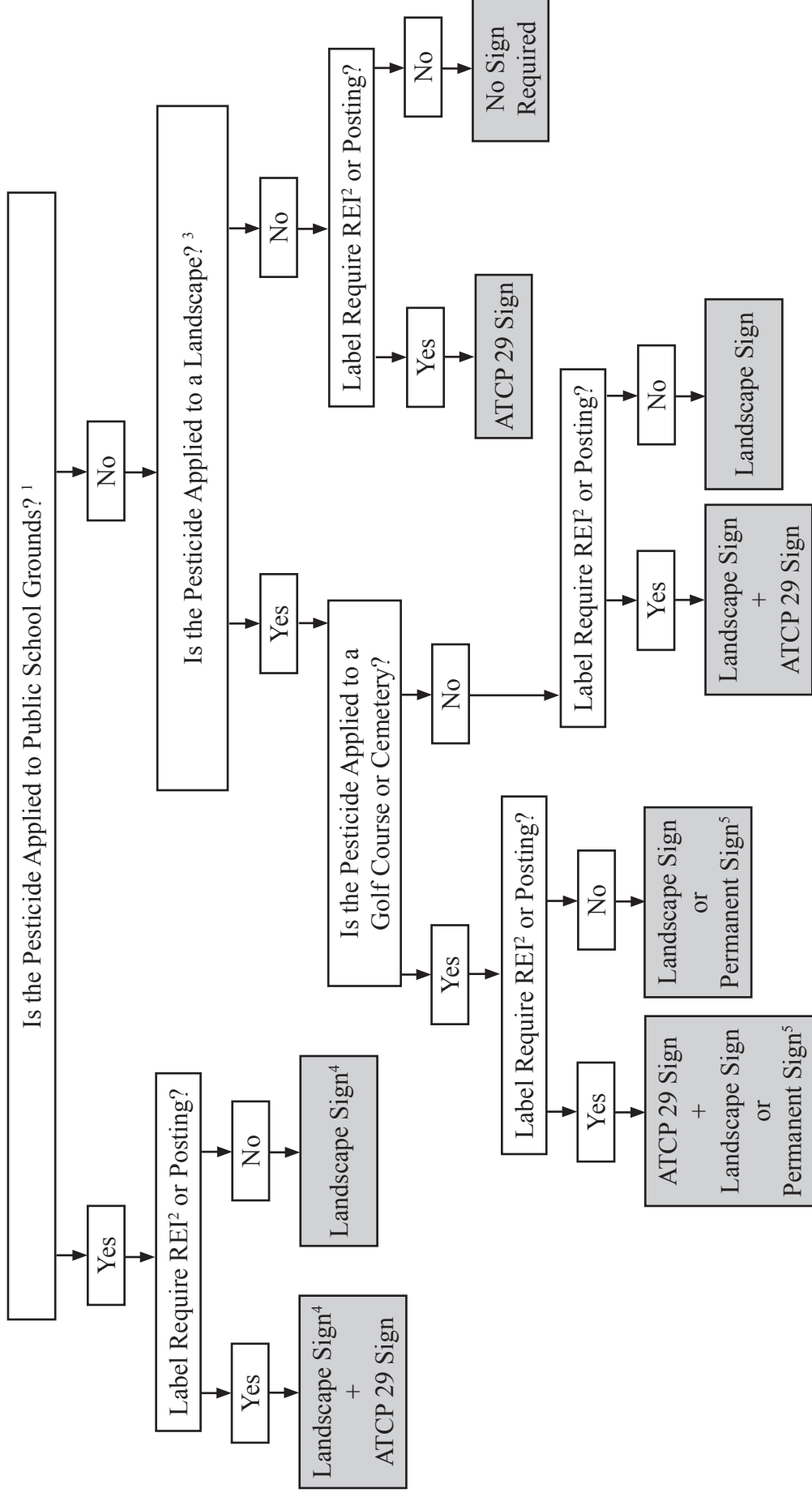


Posting Flow Chart for use in Turf & Landscape Pest Control



¹ Includes public K-12 schools; does not include private schools, day-care centers, preschools, or universities.

² Restricted Entry Interval (REI): The time after the end of a pesticide application during which entry into the treated area is restricted according to label directions.

³ By law, “landscape” means turf, ornamental and mulched areas, and areas being prepared for those purposes, that are located in or around residential premises, public or commercial facilities, parks, workplaces, care facilities, recreational areas and public lands. “Landscape” does not include utility or transportation right-of-way areas, greenhouses, nurseries, or areas used for agricultural production, forest production or commercial turf production.

⁴ If the application is to school grounds, the length of time the sign must remain posted is different than for other landscape applications. See other page of this chart for details.

⁵ The permanent sign may be used as an alternative to the landscape sign when posting these treated sites.

Note: Signs must conform to specifications regarding size, color, content and font size provided in Wis. Adm. Code ATCP29.



ATCP 29 Sign:
At least 8.5 by 11 inches.



Landscape Sign:
At least 4 by 5 inches.

Permanent Sign:
(Alternative to Landscape Sign)
At least 12 by 12 inches, with red letters on white background.

Who: The customer, the applicator, and the applicator's employer are jointly responsible for posting this sign.

Where: Post signs at each normal point of access to the treated site. If the treated site borders within 300 feet of a sensitive area where people are likely to be present (e.g., residence, school, business) during the application and/or the REI, you must also post the sign at 1/4-mile intervals along affected borders between the site and the sensitive area.

When: You must post all warning signs before the application begins and leave them up at least until the REI expires. These signs may remain posted indefinitely as long as they remain legible.

Other Information: Note that posting and REI requirements listed in an Agricultural Use Requirements section of a label pertain only to applications made on farms or in a forest, nursery, or greenhouse. Use posting and REI requirements found elsewhere on the label for turf and landscape applications. (A label that does not require posting or an REI may require that no one enter the treated area until the spray dries. In this case, you do not need to post the site with the sign.)

Who: The applicator is responsible for posting this sign.

Where: Post signs so that they are clearly visible from each point of entry into the treated landscape. Warning signs should be visible from roads, sidewalks, driveways, doorways, alleys, or adjacent yards. Warning signs are not required in areas where a fence, wall, hedge, or similar structure effectively prevents human access the entrance to a treated landscape. However, if an area is fenced, warning signs must be posted near the gate area.

When: Signs must remain in place until sunset of the day following application, and you must put the removal date on the signs. Note difference in posting time below for school grounds.

School Grounds: Note: If applying pesticides on school grounds use the sign above. However, it must remain in place for at least 72 hours following the application.

Who: Golf course superintendents or cemetery grounds managers.

Where: Golf Course—Post signs at or near the place where golfers register to play the course, and at or near the first tee of every 9 holes, and at every point on the course boundary at which the non-golfing public is permitted to enter the course by means of a road, sidewalk, path or other established thoroughfare.

Cemeteries—Post signs at each established entrance to the cemetery.

When: Permanently displayed.

Note: If a label requires different wording, use the label-specified wording in place of, or in addition to, the signs above.
