WI Landlords are allowed to charge up to \$25 for the actual cost of a credit check unless you provide a copy of your own that is no older than 30 days. Wis. Stat. 704.085(1)(a) & (b), ATCP 134.05(4) NOTE: Wisconsin landlords are also allowed to charge out-of-state applicants up to \$25 for the actual cost of a background check. Wis. Stat. 704.085(2)
