Please reach out to another youth, a leader, or a county leader for more info before growing frustrated. It also helps to not wait 'til the last minute.
- Enjoy the ride The Shawano Fair is just one place that we are able to share what we've learned. It's a great place to receive critique gracefully and get inspiration for new skills you'd like to learn. Please take some time to look around and enjoy yourself.

- Learning by Doing Blue Ribbons, Purple Ribbons, Plaques, and Chairs are all exciting! And yet, not everyone will end up with a big award. Some years, it doesn't seem to matter how much you prepare your dog may eat your knitting, your heifer may lay down in the ring and your cake may split in half. It's important to demonstrate GOOD SHOWMANSHIP or saying, "Congratulations" to the person who placed above you. Parents, Guardians, Caring Adults, and Volunteers: I'm looking at you as well. Kids model what they see. We all need to contribute for this event to happen.
- **School is IMPORTANT too!** Most youth will be starting school just as the fair kicks off. Part of being a great 4-H member is being a responsible student. Bring your math book if you'll be in the barns awhile. Please try to not get behind on school work. That being said, I have a letter that I would be happy to share with your administrator/teacher/coach to explain a bit more about what it means to be a 4-H member. ## Club Requirements: Annual Financial Forms & Bylaws

As we grow closer to the "end" of our 4-H year, we have a wonderful opportunity to review our finances and bylaws, ensuring that we are indeed in compliance with UW-Madison and the USDA.

**The Annual Financial Form** is located on our website at: https://fyi.extension.wisc.edu/shawano4h/2021/08/09/annual-financial-form/ or in person at the Shawano Extension Office. This stands as your "Charter Information" for 2021, and must be to the PYD Educator **by September 1st**. There is no grace time calculated into this. If your club does not turn the form in, you run the risk of not being chartered for the upcoming year.

Club By-laws and Charter: 4-H Club by-laws should be reviewed by your club each year. During the fall, Megan will be meeting with each Community Club leadership team (youth officers and general leaders) to review by-laws and making recommendations for changes, as well as walking through the new charter questions that are located online. Requirements for a 4-H Club and chartered Groups are listed in the Wisconsin 4-H Youth Development Policies. It is recommended that 4-H Clubs and Groups use these Sample Bylaws to write or update their bylaws. ## **Record Books**

It is highly recommended, though not required, that each 4-H member take the time to reflect on their learning in the projects they chose this year. The way that this is typically communicated is through the Shawano County Record Book Process.

Our Experiential Learning Model is: **Do. Reflect. Apply.** We want youth to take the time to think about what skills they gained, what they can do now as a product of their learning, and consider what goals they would like to set for the year to come. This year, you will have 3 options to choose from:

- 1. **Traditional Record Book:** You may choose to do the record book as you have in years past, including the "intro" sheet, "activity" sheet, and project work sheets for each project you learned in. Some project area sheets have been updated with suggested changes. You may use the sheets from last year or this year. **If you want to compete for a record book award, consider this method**. Find all materials on this page, and a sample here: Sample Record book (PDF)
- **3. Resume & Debrief:** You may choose to submit a 4- H resume to your leader and sign up for a short debriefing session with 4-H educator Megan (over the phone, in person, or through zoom). Please look at the guide: \*Resume & Debrief Guide\*, as well as two examples of 4-H youth: SHAWNA SHAWANO's RESUME and Chipper SHAWANO's RESUME. They are listed on this page as well.

This is a flexible process, and one that is improving as we go. We learn by doing. Please give us grace as we continue to make the record book process a more useful learning tool for youth and their leaders.

Record books/Basic Books/Resumes are due to your Community Club 4-H Leader at the deadline they share with you. Please have your materials to them in a timely fashion. The Record Book Rating Sheet communicates how 4-H Club Leaders will evaluate the record book at the club level. Any youth that have project records eligible for county-wide awards need their leader to turn Record Books into the Shawano Extension Office by Monday, September 20th. If your book is selected to move on to county-wide competition, the project records will be evaluated with this document: Record Book, Project Evaluation. We will keep you posted on what the county-wide record book judging process will look like in 2021. It will likely be different than previous years.



## **Livestock News**

#### Livestock Exhibitor young and not so young

If you are new to the project and wondering just how things work at the fair, there will be training JUST FOR YOU! Come to fair set up day, **Saturday August 21**, at **9am**. There will be a short (15-20 minute) informational walk-through of what to expect and what is expected of you. Experienced members are also encouraged to attend as we hope you would be willing to serve as a mentor to our newer participants. Remember how overwhelmed you may have felt that first year. This is your chance to share all you have learned over the years!

#### **Exhibitor Auction Checks**

The Extension office will e-mail 4-H General Leaders and FFA Advisors to come to the Extension office to pick up checks when they are ready. They will then make arrangements with members to distribute the checks in person. The EXTENSION office, 4-H Leaders and FFA Advisors will NOT mail checks.

#### **Passes For Animal Auction Buyers**

Shawano Area Agricultural Society, the sponsors of our county fair, adopted a policy to distribute fair admission passes to animal auction buyers as a small "Thank You" to committed buyers and a way to invite them to return this year. All <u>BUYERS</u> <u>from last year</u> will receive a one-day fair pass that they can use for free admission to this year's fair on auction day (or any other day of the fair if they so choose).

#### **Processor information**

This year past buyers will also receive a listing of processors who have reserved space for Shawano County animals. Please encourage your potential buyers to contact these processors ahead of time if they have questions about costs and how processing is completed at their own facility. This will help speed up the process at the auction.

## **County Fair Hog Exhibitors**

On Monday, the last day of the fair, from 4:00 to 4:30pm, there will be a limited number of people allowed in the hog barn to allow for group penning of hogs going to packing plants. After that is complete, we'll start taking down empty pens and getting the sawdust pushed to the center alley for a portion of the building. This will alleviate the problem of only a few people doing all the necessary clean-up work. We ask for your cooperation on this matter since it has worked very well for us the last several years.

## Cake Decorating: 4-H Cake Auction

### **Entering the Decorated Cake Auction?**

All decorated cakes that will be sold in the auction will be displayed on tables. ALL those planning to sell a cake in the auction MUST have a cake box for their cake to be displayed. As usual, the Foods Key Committee will provide a ½ sheet cake box for you that you can either pick up on Pre-Fair judging day or Thursday night of the fair in the Jr. Fair Building. If your cake won't fit, it will be up to you to provide a box that has a plastic or cellophane viewing "window".

All planning on entering a cake in the auction must bring their **completed** Cake Decorating Project Record Sheet with them to the face-to-face judging. (Need a new copy? It is understood that you will not know your results of judging but the rest must be completed and shown at judging time so that you will be eligible to sell your cake. You will be able to take this form back home with you after judging. As part of the judging process, you will also be asked to demonstrate one of the buttercream tips or fondant techniques you used in making your cake. (All supplies will be provided.)

Auction checks will be available for pick up at Monday night check out.

#### **VOLUNTEER BEHAVIOR EXPECTATIONS**









#### VOLUNTEER BEHAVIOR EXPECTATIONS

These expectations serve as a guide for behavior during volunteer service. You will need to acknowledge you have read, understand, and agree to the terms and conditions of volunteer service. If you have questions, contact your county Extension office.

#### As a Division of Extension volunteer, I agree to:

- Conduct myself in a manner that is in the best interest of the Division of Extension and the program(s) for which I
  volunteer.
- Work cooperatively with others, including Extension staff, volunteers, program participants, and community members, to further the mission of my volunteer program and the Division of Extension.
- 3. Accept supervision and guidance from Extension staff or designated management volunteers.
- Treat all people with respect, use courteous manners and language, exhibit good sportsmanship, be a positive role model, and use effective conflict resolution skills.
- Complete tasks, reports, and evaluations within the agreed upon timeframe. When I am not able to complete something within the agreed upon period, I will let staff or designated management volunteers know I am unable to do so.
- 6. Take part in orientation and training programs designed to help me deliver programs more effectively.
- 7. Use appropriate resources, including research-based information from the university, when delivering programs.
- Support inclusion by making all reasonable efforts to ensure that programs are accessible to all individuals in the communities we serve.
- Refrain from engaging in any form of abuse, harassment, neglect, or <u>discrimination</u>, <u>and report</u> anyone who engages in this type of behavior when involved in Extension programs to appropriate university and law enforcement authorities.
- 10. Abide by all University of Wisconsin-Madison and Division of Extension rules, regulations, and procedures (e.g., youth/vulnerable populations protection policies) and with any federal, state, city, or other laws and rules that are applicable to the location where the activity is occurring. This includes USDA rules, policies, and guidelines.
- 11. Treat animals in a humane manner and teach program participants to provide appropriate animal care and management.
- Refrain from consuming or being under the influence of alcohol or illegal substances while serving in the role of a Division
  of Extension volunteer and forbid youth participants under my supervision from doing so.
- 13. Refrain from conceal carry of firearms and/or weapons while serving in the role of a Division of Extension volunteer. I understand that if I am a 4-H Youth Development shooting sports volunteer, I am expected to openly carry/transport 4-H shooting sports equipment in designated areas.
- Refrain from participating in any political campaign activity and expressing personal political views while serving in my
  volunteer role.
- 15. Refrain from using my volunteer position or title for my own private or personal gain (e.g., securing university contracts).
- 16. If approved to drive by UW-Madison as part of my volunteer role, I will operate all motor vehicles and other equipment in a safe and reliable manner and only with a valid operator's license and the legally required insurance. I will comply with all motor vehicle-related state regulations and laws.
- 17. Self-report to my Division of Extension supervisor or other point of contact about any changes in my status (e.g. criminal arrest, charge or conviction history, driving privileges, etc.) in accordance with the UW-Madison Criminal background check policies and/or within 24 hours or at the earliest possible opportunity; also, I will inform Extension about any new criminal activity, arrests, or convictions that involve another Extension volunteer or staff member within 48 hours of learning about the situation.

I have read, understand, and agree to abide by these expectations for volunteers. I understand that suspension or termination of my position as a volunteer may result if I do not meet these expectations.

Your Club Leader will contact you when your fair entry tags are ready (the middle of August). There are no fair tags printed for <u>large animal</u> entries, but everything you entered will be on a confirmation page printout-check this page for correctness ASAP.
