Old Business:

- 1. Committee Reports

It was mentioned that Lindsay Johnson wanted to see a meat judging team in Shawano and was looking for feedback and had posted it on Facebook. Eli talked to all Adult and Youth chairs regarding the possibility of having an ultrasound/carcass clinic done by Dr Ryes. Eli and Emma to contact him for more information. Kelli looking for permission to earn 2 educational credits by doing a job shadow with Greenstone Farm Credit Services. Board had no issues with this. A beef fitting clinic is scheduled for June 27th @ 5:30 pm.

- 2. Ag Society
 - a. Pig Barn roof being contracted out and will be completed prior to 2024 fair
 - b. Survey being done on Air Movement within buildings. Rabbit/Poultry barn will be looked at.
- 3. Two Signature Check
 - a. No longer a discussion as this was not tabled in December. Discussion was regarding a Co-Treasurer position where one person would take care of check writing duties and the other person would audit all the books. Sam asked when Nancy was retiring. Nancy stated yesterday was her last day.

She went on to explain her duties, it's challenges and what she believes is required in a Treasurer. After additional conversation, she did say she was willing to train and shadow the replacement.

New Business:

- 1. By-laws
 - a. Should By-laws be updated for two signature checks? Nancy pointed out that Credit Card for Leaders Inc was used to do all purchases and there was discussion surrounding that and why that was occurring. Nancy also stated Kerber Rose does not do things timely and constantly filing for extensions. The latest extension caused the Livestock Committee to pay an additional \$700+ in fines as Kerber Rose missed extension deadline. Paul was looking for discussion on how to proceed but no one commented. No discussion on any changes. Terri asked about what type of advice Kerber Rose gave Nancy regarding having account audited and Nancy said nothing was ever said and no audits were ever done. Gina asked if Treasurer position should be paid as there was so much work involved. Bill Inman stated that more than just the Treasurer do a lot of work too and no one else received compensation as all the roles are voluntary. Mandi suggested advertising position & looking for others who might be interested in the treasurer position. Heather pointed out that By-laws could be amended at any time. Paul ended discussion and stated we are moving on to next topic.

Jeff H asked why Nancy is leaving now when he was under the understanding from previous meeting discussions that she agreed to stay until elections in November. Further discussion was had on appointing individuals and/or special elections.
