## Fox River Ecosystem Partnership

- FREP established in 1996
- FREP's territory is the entire Fox River watershed in Illinois
- One of 41 ecosystem partnerships in the state under the auspices of the Illinois Department of Natural Resources
- Conduit for State and Federal grants

Watershed Facts
In Illinois

- 1,720 square miles
- 130 miles in length
- 9 counties
- Over 90 communities
- Over 400 lakes
- Land cover/use: wetlands, recreation, urban, farming, scenic



#### Vision and Goal

- Our Vision for the Fox River watershed in Illinois is to balance all the uses and demands on our natural resources while preserving and enhancing a healthy environment.
- Our Goal is to promote, preserve, protect and enhance the natural, cultural, economic and recreational resources of the Illinois Fox River and its watershed.

Organization Structure

- Not-for-profit group
- Funding is mostly membership based and some grant funding
- All are welcome: individuals, businesses, organizations, government entities, HOA, consultants
- One paid Communications Manager
- Executive Committee oversees activities
- Integrated Management Plan





## Factors Impacting the Fox

- Population Growth and Development
- Regulated Discharges
  - 160 NPDES permits
  - 55 WWTP on Fox and Tributaries in IL
- Water Supply
  - Over 300,000 people drink from Fox
- Dams
  - 13 on Fox in IL, 80+ on tributaries
- Wisconsin—what happens upstream



### Integrated Management Plan

- Collaborative, Inclusive Process to establish
- 6 Areas of Concern
  - Recreation, Habitat, Land Use, Water Quality, Stormwater, Education
- 16 Critical Factors
- 37 Recommendations for Action
- Endorsed by municipalities, counties, conservation and park districts, environmental consultants, environmental groups and more



# Fox River Watershed Grants and Matches

- Lead effort in grant writing review
- FREP instrumental in bringing \$\$ to watershed
- IDNR C2000 \$2,333,250
  - 58 grants since 1996
- EPA319
- \$9,500,000
- 47 NPS Pollution Control Grants since 1990



#### FREP Activities

- Bi-monthly FREP Noon Network programs featuring environmental projects throughout the watershed
- Bi-monthly membership meetings with program
- Assisting CMAP with 9 lakes TMDL project
- Provided Watershed Planning assistance for four subwatersheds: Blackberry Creek, Ferson-Otter Creek, Silver Creek and Sleepy Hollow Creek
- Collaborated with the Conservation Foundation on the Preserve the Fox Guide and Website

- Kane County Rain Garden Initiative
- Annual Conversations about Conservation with our Legislators
- Municipal Smart Growth/BMP Workshops
